Minutes of the Kirton in Lindsey Town Council Meeting held on Wednesday 24th February 2016 at 7.00pm in the Town Hall, High Street, Kirton in Lindsey, DN21 4LZ

Present – Councillors: Cooper (Chair), Startin, Layzell, Davies, Frankish, Cossey, Boyd Ward Members Cllr England and Cllr Poole

Before the meeting commences Tim Allen of NLC will give a talk and answer questions on the Parish Paths Partnership

The scheme was devised by the government to give councils the opportunity to care for the footpaths. Extra funding has been allocated for the project for councils to take on a contractor to care for the footpaths, convert stiles and gates, add additional signage etc. The process involves a simple agreement between the council and NLC. Contractors will be paid upfront by NLC to avoid having to pay out and reclaim costs. Definitive maps can be provided showing where cuts can be cut with a tractor and where strimming is required. NLC would be responsible for enforcement on private land where there are crops etc. The council would have access to NLC to address with any legal or enforcement issues. Extra hours for the Clerk could also be paid for by NLC should this be necessary. Agreements are standard but will be flexible to allow for new paths etc. A list of approved contractors can be provided. The agreement could also be terminated any time the council choose as NLC would still retain responsibility. Councils could also take on responsibility for adjoining paths.

Public Participation

A member of public spoke about the private road on The Green. A long discussion ensued, the Clerk arranged to meet with residents to discuss the issues. Issues with litter were raised; the Clerk would speak to contractors to ensure that the bins were being emptied weekly.
