**Public Participation:**

Two members of the public spoke regarding the licensing application for the First and Last. He lived near the pub and was concerned about the application. He believed that the opening hours were excessive and would create disturbance until the early hours of the morning. The noise generated outside and the behaviour of those leaving in the early hours, along with the accompanying music license, were of concern, as the pub is in a residential area.
