



**Minutes of the Extraordinary Meeting of Kirton in Lindsey Town Council

## MINUTES

2303E/01 Apologies for Absence

2303E/02 Declaration of Interests / Dispensations

2303E/03 Outdoor Gym Equipment  
The Council considered quotations received and responses from residents to the public consultation regarding funding from North Lincolnshire Council for outside gym equipment at KLASSIC Park.

The Council were informed of the results of public consultation with residents, noting 196 responses received although not all questions were answered by all who responded. In response to the proposals they would most like to see implemented at KLASSIC, 173 residents answered. 102 (58.96%) choosing Streetscape; 75 (43.35%) choosing The Great Outdoor Gym Company; 71 (41.04%) choosing Kompan; 18 (10.40%) choosing Proludic; 9 (5.20%) choosing Wicksteed (Option 1) and 7 (4.05%) choosing Wicksteed (Option 2).

The Council discussed accessibility and inclusivity and noted that adjustments could be made to make any of the options more accessible for all.

The Council discussed if the full funding would be coming from North Lincolnshire Council, the question of inspections and ongoing maintenance costs, the ownership sitting with the Town Council or KLASSIC Park, insurance considerations, the cost of the first annual servicing of equipment and cost of the first years' insurance.

**RESOLUTION: That the Streetscape option is the preferred choice and this is communicated to North Lincolnshire Council in order that the purchase and installation can be progressed.**

**RESOLUTION: That the full £25,000.00 offered in funding is requested from North Lincolnshire Council so that adjustments can be made for greater accessibility and inclusivity for the provision.**
