- GP2409/01 Apologies
Apologies were received from Cllr Adam Delsignore and Cllr Joy Kofoed.
- GP2409/02 Declaration of Interests / Dispensations
a. No declarations of interests were declared.
b. No dispensations were granted.
- GP2409/03 Public Participation
No matters were raised.
- GP2409/04 Minutes of the Previous Meeting
The Committee considered the minutes of the General Purposes Committee Meeting held on 8th July 2024.
RESOLUTION: That the minutes be signed as a true and accurate record.
- GP2409/05 Local Plan Consultation (Lincolnshire)
The Committee received a request for consultation from Lincolnshire County Council regarding the Minerals and Waste Local Plan Preferred approach.
RESOLUTION: That thanks are given for involving the Town Council in the consultation. As immediate geographic neighbours the Council wish to express general concerns over any environmental impact which may adversely affect the town's population through loss of residential amenity and increased heavy goods vehicle traffic. ACTION: Town Clerk
- GP2409/06 Allotments
The Committee received the pre-planning advice from North Lincolnshire Council (NLC) for the works agreed to the entrance to the allotments site. The Clerk noted that professional support would be required for some of the reporting requested. Cllr Stephenson suggested the NLC planning team may be mistaken about the need for the application due to the location of the allotments. Cllr Garritt offered to assist with clarifying the information required. Cllr Frankish noted that the tenants should be updated on the current position. The Clerk noted concern about the delay the work required will cause to resolving the access issues into the site for allotment tenants.
RESOLUTION: That Cllr Garritt meets with the Town Clerk to go through the requirements. ACTION: Cllr Garritt/Town Clerk
RESOLUTION: That an update is prepared for the allotment tenants. ACTION: Cllr Frankish
RESOLUTION: That an update is given at the September Full Council Meeting. ACTION: Town Clerk
- GP2409/07 Police and Crime Commissioner Funding
The Committee considered details of the Community Safety Fund Round 5 in terms of potential projects and next steps. The Clerk provided details around potential CCTV provision for the Market Place to link to the Security Control Centre, Scunthorpe as a possible project. Cllr Cooper noted concern about safety at the pedestrian crossing at South Cliff Road and for consideration to be given to a project to help with this. The Clerk noted that a financial contribution to any project would be required from the Town Council.
RESOLUTION: That an application is made to the fund for CCTV provision for the Market Place linked to Security Control Centre, with a 10% financial contribution towards the project from the Town Council. ACTION: Town Clerk
RESOLUTION: That some advice is sought from the Chair of the Diamond Jubilee Town Hall Trustees around the application prior to finalisation. ACTION: Town Clerk
